Sub:- Accounts - VUDA - request of Sri B.U.S.Subrahmayam Sr.Asst. for reimbursement of medical expenditure of his daughter - payment of lumpsum amount inlieu of reimbursement-reg.

AGENDA NOTE :

Sri B.U.S.Subrahmanyam, Sr.Asst. has put in a representation dt.11.12.99 stating that his only daughter aged 14 years was suffering from Thalassemia Major since her birth, which is a genetic disorder. Treatment comprises blood transfusion for three times on average per month. His daughter was treated in City Hospital and the average monthly expenditure for the treatment of baby is Rs.6750/-. As the monthly expenditure is more than his salary, he requested for reimbursement of actual medical expenditure. He had submitted the certificate issued by City Hospitals, Visakhapatnam stating that Kum.Sai Maithili, D/o Sri B.U.S. Subrahmanyam, is suffering from Thalaemia Major and she needs blood transfusion 3 times per month and the approximate monthly expenditure for the treatment of baby would be Rs.6750/-.

The request of the individual was placed before the Board. The VUDA Board in its resolution No.435, dt.2-11-99 had resolved to reject the request of Sri B.U.S.Subrahmanyam, Sr.Asst. for reimbursement of actual medical expenses per month amounting to Rs.6750/- per month for treatment of his daughter and also resolved to request the Vice Chairman, Chairman to examine the rule provisions for payment of lumpsum amount if any (i.e., one time grant) to send necessary proposals to Govt. for suitable orders in the matter.

Subsequently, the daughter of the individual died on 21-12-1999.

As per G.O.Ms.No.86, on 1-6-92 and G.O.Ms.No.38, dt.23-1-96 the Govt. employees are entitled for sanction of medical expenditure as advance upto Rs.50,000/- for treatment of following diseases.

1. Acute my cardial infraction (Cardiology Dept)
2. Acute renal failure (Nephrology Dept)
3. Severe cases of head and spinal injury (Neuro surgery Dept)
4. Cases of Coma (Neurology Dept)

The diseases of the daughter of the applicant i.e. Thalsassemia Major (Genetic disorder) is not one of the diseases covered under I.M.A.Rules of 1972 or in the above Govt. Orders for sanction of advance in lumpsum.

In view of the resolution of the Board to recommend to Govt. for payment of lumpsum amount if any i.e., one time grant and inview of reimbursement of Rs.50,000/- to Govt. Employees for four diseases as per the above G.Os. it is proposed to recommend to the Govt. for payment of Rs.50,000/- as one time grant.

The matter is placed before the Board for approval of the above proposal.

VUDA RESOLUTION NO.534 DT.30-3-2000

Resolved to recommend to the Government for payment of lumpsum amount i.e. one time grant towards medical expenditure of the daughter of Sri B.,Subrahmanyam, S.A. who suffered from Thalsassemia major (Genetic disorder) and who expired on 21-12-99.
