ERRATA TO SUBJECT NO. 28

Read further note dated 7-5-70 of Trust Engineer-Town Planner stating that T.S.Nos. 91, 92 and 85 (1) A of S.T.Ward have to be acquired and T.S.Nos. 45/2, 45/3, 85/2, 85/3, 85/4, 85/5, 85/6 and 85/7 of S.T.Ward may be dropped as per the alignment of Cathedral street widening.

SUBJECT NO. 68.

Read letter Roc.No. 7700/195/F2-70 dated 9-3-70 of the Examiner of L.F.Accounts, A.P.Hyderabad requesting for the advance payment of Rs. 6,346/- towards cost of audit for the continuance of one post of Head Clerk for the audit of accounts of the Town Planning Trust for a further period of one year from 2-6-70 to 1-6-71.

Read office note dt. 11-5-70 thereon.

The Trust is requested to accord sanction for the payment of Rs. 6,346/- for conducting the audit of accounts for 68-69.

SUBJECT NO. 69.

Read the recommendations of the building applications committee made in Resolutions No. 7 and 8 dated 7-5-70 (copies enclosed).

The Trust is requested to approve the same.

SUBJECT NO. 70.

Read letter dt. 5-5-70 of Sri K.S. Dutt, while stating among others requesting to restrict the widths of the three roads around Sri K.S. Dutt's bungalow to 50' as against 80' in respect of the two roads leading to Circuit House and Peda Waltair i.e., Karakachettu Road and 60 feet in respect of the road leading to the Traveller's bungalow as proposed in the Master Plan and D.T.P.Scheme.

Read T.P.T.R.No. 106 dt. 20-10-66 wherein the Trust on a similar representation made by Sri K.S.Dutt, resolved to reduce only the widths of the road opposite to the Imperial tobacco to 60' instead of 80' and declined to agree with the other proposals.

The Trust is requested to reconsider the matter for forwarding to the Director of Town Planning (Andhra Pradesh) Hyderabad.
