Sub:- VUDA – Visakhapatnam – Establishment – Extending eligible benefits to certain Work Inspectors – proposals – Submitted.

**AGENDA NOTE :-**

There were a total no. of 144 R.NMRs working in VUDA and among those 14 R.NMRs were appointed as T.W.I. (W.I.Gr.III) as per their qualifications, ie., higher cadre than that of R.NMRs.

The above, R.NMRs including the Technical Work Inspectors were extended some benefits such as leave, medical, bus pass, G.I.S. etc., on par with regular employees of VUDA in the year 1994 and these benefits were stopped by VUDA later on administrative grounds. The same benefits which were being enjoyed by the works-Inspectors were also stopped by the VUDA along with R.NMRs.

The Govt. in G.O.NO.457,M.A.,Dt.9-10-2002 have ratified the orders of Vice-chairman in regularizing the services of 93 R.NMRs, on the request made by the VUDA treating all the 93 R.NMRs as Last Grade Servants duly extending benefits on par with regular employees of VUDA. Therefore, these 14 Technical Works Inspectors (Gr.III) for all practical purposes are equalent to the L.G.S. as covered in the above G.O. as they were brought from R.NMR cadre and as they are seniors and more qualified than some other R.NMRs covered in the G.O. The only lapse in that at the time of sending the proposal to the Govt. for ratification orders, these 14 W.Is were not included in the proposal as they are in higher cadre and regular scale of pay and increments are being sanctioned to them and sought for regularization of 93 R.NMRs only. Accordingly the Government have ratified the action of regularization of only 93 R.NMRs as sought for by the VUDA. Hence, these 14 W.Is who were once R.NMRs for all practical purposes.
