SUB: Works – Engg. – V.U.D.A. – Rejunevation of Pedda Tank – Administrative Sanction accorded – Tender accepted – Perusal and Ratification – Reg.

## AGENDA NOTE:

In accordance with the decision taken during the discussions of Town Development Committee Meeting of Vizianagaram, it is propoosed to take-up the project "Rejuvenation of Pedda Tank and convert into Recreational Centre". The main object of the project is to coîlect the influents let-out into Pedda Tank and creating the influents so as to have safe/hygienic effluent and disposal for irrigation purpose.

Accordingly proposals were initiated for Rejuvenation Pedda Tank with an estimated cost of Rs.204% lakhs based on the project of Rejuvenation of Hussain Sagar at Hyderabad.

For taking up this work it is proposed to utilise the funds from sale proceeds old R.D.O. Office site and no V.U.D.A. Funds are involved.

The proposal comprises of providing screens, drain arrangement for connection of inlets, providing Deep ponds for sludge depositing for long period aeration and landscaping of bunds etc.

The Hon'ble Chairman, VUDA and Vice-Chairman, VUDA have accorded Administrative Sanction for Rs.204.00 lakhs and permitted to take-up the component of civil works and designs amounting to Rs.166.00 lakhs by way of calling tenders.

Accordingly the Tenders were called for vide C.T. Notice No.5/2003-04/CE/VUDA dated 4.7.2003. The Tender Notice was also published in News Papers in 'Deccan Chronicle' and 'Eenadu.' Daily editions While inviting tenders Eligibility

Criteria has stipulated for participation in Tenders duly fixing Mile Stones and Penal Clauses in case of not adhering to the achievements.

The Tenders were opened and evaluated as per the Norms fixed by the Government and Eligibility Criteria stipulated.

In response to the Tender Notice, 3 Nos. applied for Tender Schedules and 3 Numbers have taken. Only Two tenderers have submitted their tenders along with the requisite E.M.D.
