Sub:- U.D.A.-Vsp. - Estt. - Extension of Terminal benefits to the deceased RNMRs on par with L.G.S. as covered by G.O MS.No. 457, dt. 9-10-02

## AGENDA NOTE:

The Urban Development Authority Visakhapatnam has placed the N.M.R.s in the minimum of time scale of last grade servants after completion of 5 years of service from time to time. Thus a total no. of 144 N.M.R.s were placed in the minimum of time scale of last grade servants from 6-2-1990 to 1-6-1992. The VUDA Board in its Resolution No.115,dt.17-6-1992 have resolved to approve the orders of the Vice-chairman in placing the N.M.R.s in the minimum of time scale of last grade servants.

The VUDA has extended the benefits such as leave, medical, bus pass and Tution fee, TA, DA, GPF, GIS and all advances as per Rules to the 144 RNMRs vide proceedings Rc.No. 1696 / 78 / A3, dt.4-10-94 on par with regular employees of VUDA. Later the extended benefits were stopped on some administrative grounds.

The Government have ratified the action of the Vice Chairman in his proceedings No. 1696 / C / 78 / A7 dt. 4-10-94 in having regularized the services of 93 NMRs on par with the regular employees of VUDA as Last Grade Servants. At the time of sending the proposals to the Government only 93 RNMRs were recommended for ratif. after excluding the RNMRs who were absorbed as Asst. Engineers, Junior Assistants, 1 racers, Technical Work Inspectors etc. and those who left the organistation for various reasons and those expired while in service as RNMRs and the names of degeased RNMRs were not included in the proposal as they were expired at the time of sending proposal to the Government. Accordingly the Government approved only the 93 RNMRs leaving the other RNMRs as proposed by the VUDA. The Government have ratified the proceedings Rc.No. 1696 / C / 78 / A7 dt. 4-10-94 of the Vice Chairman, VUDA in which all 144 RNMRs were extended the benefits, vide GO.Ms.No. 457 MA dt. 9-10-2002

The following 8 deceased RNMRs are also covered in the proceedings Rc. No. 1696 / C / $78 \mathrm{~A} 7 \mathrm{dt} 4-10-94$ and details are as follows :

Some of the spouses of the above deceased RNMRs have represented for sanction of Terminal benefits on par with the 93 RNMRs who are treated as Last Grade Servants as approved in Government G.O.Ms.No.457.dt 9-10-02.

As the services of the above 93 RNMRs who were actually regularized as per the orders of the Vice-chairman, for all practical purposes the deceased RNMRs are last grade servants since the Government have ratified the action of the Vice-chairman in regularization the services and extended the benefits in proceedings Re.No. 1696 / C / 78 /A7 dt. 4-10-94. As such the above 8 deceased RNMRs are entitled for all the benefits on par with the 93 other LGS as they were already covered in the above proceedings which was ratified by the Government.

Hence the matter is placed before the VUDA Board for approval to extend all the benefits to the above 8 RNMRs who were expired after regularization of their services on par with the 93 RNMRs who have been treated as LGS as approved by Government in G.O. Ms. No.457, dt.9-10-02, under intimation to the Government.
