Sub: VUDA., Visakhapatnam –Land Acquisition Unit headed by the Special Deputy Collector, Land Acquisition – Further continuation – Regarding.

## AGENDA NOTE:

The Government in their letter No.19926/B1/2002-1, M.A., dt.30.12.2002 have issued orders to reduce out of the existing posts in Special Deputy Collector, Land Acquisition to that the minimally required skeleton staff for not more than the period up to 30.4.2003.

The Spl. Dy. Collector, L.A., VUDA in his letter dtd.27.1.2003 stated that there are land acquisition at 4(1) stage Ac.292.00 cases covered by 7 villages and 41 Acs. of preliminary valuation stage covered by5 villages, 16 Acres at Award stage covered by 2 villages. Another 300 acres are being identified at Bheemili mandal for which land acquisition has to be initiated verification of the Mandal Revenue Office records are in TUV progress. Besides that, there are 246 cases pending at various courts for which the old records are to be verified and the information is to be furnished to the various courts and there are 114 LOPs pending at various courts for deciding the cases of section 30 and 1829 31(2) of the Land Acquisition Act.

The Spl.Dy.Collector, L.A., VUDA in his letter dt.27.1.2003 has requested the District Collector, Visakhapatnam to address the Government for further continuation of the entire sanctioned staff for one year i.e., up to 30.4.2004 in the interests of the workload and as well as the administration. Hence the District Collector, Visakhapatna in his letter Rc.No.3047/2002/G1/dt.6.2.2003 has requested the Vice Chairman, VUDA, Visakhapatnam to continue the existing staff of the Spl.Dy.Collector, L.A., VUDA for one more year i.e., up to 31.3.2004 in view of the workload.

The work load has been increased recently due to initiation of fresh land acquisition at Kapuluppada and Mahdurawada Road (Mini city) and Jammunarayanapuram Village at Vizianagaram. The work load has been increased due to continuous court litigations arising in various awards.
