Agenda Note:

The VUDA has constructed 3 more floors i.e., 7^{th} , 8^{th} & 9^{th} floors on the existing floors of Udyog Bhavan Complex of Block-B. It is proposed to shift the entire office of VUDA presently situated in the 3^{rd} floor & 5^{th} floor of Block-B building and in the 2^{nd} floor of the Block-C building, to the newly constructed 7^{th} , 8^{th} & 9^{th} floors of Block-B building.

Therefore it is proposed to design the above floors with the interior designs in such a way for moderate corporate office. In this regard, M/s. TRIAD, Architects & Interior designers of Visakhapatnam have been requested to furnish their proposals for designing of the interiors for the proposed interiors of the VUDA office for the 7th, 8th & 9th floors of Udyog Bhavan Complex. Accordingly, they have furnished their proposals vide letters dated 17.3.2006 and 1.4.2006 with the following scope of work and the consultation fee quoted by them is 4% on the total cost of the construction. It is negotiated with the firm and agreed by them @2.50% instead of 4%

a. Take the measurements of the site, other details from the client and requirements of the client for various departments and the connectivity of the same.

b. Preparation of conceptual layouts and design concepts for the organization.

c. Preparation of 3D images for the design on layout approval.

d. Preparation of estimates for the approved design.

e. Preparation of detailed working drawings for the approved design.

f. Preparation of electrical, sanitary and plumbing drawings.

- g. Preparation of all custom made furniture and also any other as required by the client for this project.
- h. Preparation of B.O.Q for the entire project elements
- Co-ordinate, work on the selection, quality, specifications & preparation of the furniture with VUDA as per the requirements.
- Suggest fire safety equipment required in for such type of interiors & Co-ordinate with VUDA on selection and finalization of specifications, brands and overall layout.
- k. Complete Co-ordination work with the in-house electrical works computer networking system in-charge or consultant appointed for the purpose as the case may be.
