Sub: VUDA - Works - Engg. - Providing BT surface on existing of WBM surface to approach road of Forma city in E-Bonangi, RH Colony at Parawada, Visakhapatnam - Draft subject is placed before VUDA Board - Ratification - Requested - Reg.

Agenda Note:

It is to submit that while enclosing the representation of President, Praja Nirvasitula Sankshema Sangam, E-Bonangi, RH Colony, Parawada (M) in the reference cited above, Hon'ble MLA Sri Panchakarla Ramesh Babu, Pendurthy Constituency Parawada Mandal, Visakhapatnam requested Vice Chairman, VUDA to take necessary action to lay BT surface to the approach road to the Pharma City, RH Colony at Parawada, Since the existing WBM Road is damaged completely as a result public of the local villagers have been suffering a lot.

Thereupon the matter is examined by the Planning & Engineering Wings of VUDA and following observations were made

The said 80'-0" road is not a Master Plan Road. But it is the only available road to cater the needs of E-Bonangi Village, beneficiaries of the layout developed in bulk land sold by VUDA, residents of Rehabilitation Colony and NTPC Layout.


Previously WBM road was constructed with the funds deposited by the Plot owners for development in all the three layouts measuring an extent of Ac.20.12 Cts. carved out in the lands allotted by VUDA during the year 2005. Moreover part of this road was already covered in one of the above layouts. The length of the road is 1.20KM.

Since the existing WBM surface was completely damaged, it is necessary to protect the road by laying BT surface and construction of side drains including one cross drainage work. And as the issue was represented by local MLA taking into account of difficulties experienced by villagers in the interest of public welfare it is desirable to consider the request.

In view of the above, it is proposed to take up black topping work with BT Macadam & SDBC layers including CC drains on both sides of the road and one slab culvert with an estimated cost of Rs 69.00 Lakhs.

The Vice Chairman, VUDA accorded Administrative Sanction for Rs.69.00 Lakhs for the subject work and permitted to take up the work by way of e-tenders.

Hence the matter is placed before VUDA Board for perusal and ratification.
