

**SUBJECT NO. 1151****AGENDA NOTE:**

In pursuance of the Minutes of the VUDA Board meeting dt. 15-9-2011, the Government were requested to sanction one Director for planning and to sanction some more Additional Posts with a request to ratify the sanctioned strength made by VUDA Boards from time to time duly taking into consideration the recommendation made by the Centre for Good Governance for regularization of staffing patterns in Urban Development Authorities. The reply in the matter is still awaited from the Government.

It is further submitted that in the minutes of VUDA Board meeting held on 15-9-2011 it is observed to have the services of the one Director Planning, Two Additional Directors Planning and One Assistant Director/ Dy. Director Survey and Land Records.

Further in view of the dearth of staff in all cadres, the following requirement is identified by all the Head of Departments who requested to provide the services immediately in view of the existing workload on hand i.e. preparation of Master plan for VMR & VPCPR and construction of various projects like Raw Housing scheme, Haveli and YSR Park and such other works.
