An extent of Ac 2.15582 sq ft in T.S. No 83/1 of Wallair Ward was acquired by VUDA vide Award No 3/82 dt 20-21982 and the compensation of amount of Rt. 7.83 loshs was deposited in Civ. Court v/s 0.8 3 1/2 of L.A. Act os the land ownes tailed to prove their title over the land. The possession of the acquired land was handed over to VUDA on 3-12-1983 invoking the provisions of Section of a L.A.C. Accordingly the said land acquisition attained finally under the low. But the landowners i.e. \$i. \$5. Noido and others have carried titipolion laking advantages of loopholes in the administrative decisions which have now resulted in favorable orders to landowners vide Horn'ble High Court Judgement in W.P.No.47.5 i. 1455 of 2011 (dt 24-1-2012.

The acquired land Ac2.15582 sq.ft in T.S.No.83/1 of Waltar Word is located in centre of Visikhopatnam City and just behind the VUDA. Complex which has commercial value to a time of Rt.100 Crores. Keeping in view the importance of the property, the Govt. wide Letter No.10086/H2/2003 at 5-5/2012 has permitted VUDA to file on Special Leave Petition in the Hon but Supreme Court of India against the Hon-ble High Court Judgment in W.P.No. 475 & 1455 of 2011. In this regard, action is being taken to file Special Leave Petition in the Supreme Court Ihrough the Advocate On Record/ADR) at Supreme Court. New Dehit. However, since the value of the property is above fit. 100 crores, the opposite party would engage Senior Advocates in Supreme Court I defend their stand. Hence it is very important for VUDA to engage a Senior Coursel opart from Advocate On Record to represent the case properly to tadeguard the Rt.100 Crores worth property of VUDA.

The matter is placed before the Hon'ble VUDA Board for according sanction of engaging a Senior Counsel in the Hon'ble Supreme Court to detend the case properly to safe guard the 100 crores worth properly of VUDA.
