Agenda Note

Earlier, VUDA was requested to provide funds to a tune of Rs.19.00 Crores for Conversion of Visakhapatnam – Bheemili Beach road into four lanes based on the letter of Engineer-in-Chief, R & B Dept., addressed to Principal Secretary to Govt., TR & B Dept. citing the G.O.Ms.No.87, TR & B (R1) Dept., Dt.3-9-2012 wherein the cost of Land Acquisition and other accessories are to be borne by the concerned Urban Local Body vide references 1st and 2nd cited above.

Thereupon Government was informed that it is highly impossible to spare the funds to a tune of Rs.19.00 Crores towards the said purpose considering the overall fiscal position of the organisation and implications of pending works and commitments to be completed by VUDA.

Despite the existing constraints, keeping in view of the development and as expansion of the road is within the jurisdiction of the VUDA, it is informed that an amount of Rs.10.00 Crores can be spared for the said proposal duly taking the approval of VUDA Board. On placing the subject matter before VUDA Board meeting held on 20-7-2013, it is resolved that "The proposal for sparing of Rs.10.00 Crores to R&B was not considered" and the same was informed to Government vide Letter in the reference 5th cited above.

However, it was informed vide reference 6th cited above, that Government have decided to provide the municipal funds for conversion of Visakhapatnam – Bheemili beach road for stage-I activities i.e., Land Acquisition and Shifting of utilities by VUDA with cost of Rs.18.90 crores and same was approved at the Government level. As such, Vice-Chairman, VUDA was requested to take necessary action for providing funds for Stage-I activities with cost of Rs.18.90 Crores and report compliance.

In the above circumstances, the subject matter is placed before VUDA Board for kind perusal and to take a decision on the above regarding release of funds as directed by the Government.
