AGENDA NOTE:

VUDA has taken up Development and Widening of Master Plan Roads in Madhurawada and its surroundings to provide better connectivity and diversify the population growth in Visakhapatnam city. These Master Plan Roads are proposed to open up new areas and to cater the future needs of residential colonies and up-coming developments in Madhurawada, Yendada and Rushikonda areas.

The following is the status of Master Plan Roads taken up and completed in the recent past and on-going at present:

In addition, two more Master Plan Roads are proposed to take up considering the importance and necessity for connecting NH-5 in Madhurawada area based on the request of Hon'ble MLA, Bheemili and GVMC Authorities and following are the details.

The above two Master Plan Roads are very important to widen and develop the same in view of the establishment of Educational Institutions, development of private layouts and housing colonies and increase in traffic density, since the existing road with single carriage way is in bad shape (4.00 M wide) and not catering the needs of public and many representations are being received from Bakkannapalem and Nagarampalem Villagers.

Further, the Hon'ble Minister for Infrastructure and Investments and Ports, Sri Ganta Srinivasa Rao, has laid the foundation stone for the above two Master Plan Roads on 15-02-2014 in anticipation of approval and Administrative Sanction of Vice-Chairman, VUDA. The functional arrangements for laying foundation stone were made by GVMC Authorities.

Hence the matter is placed before VUDA Board for perusal and approval for taking up the said Master Plan Roads with an estimated cost of Rs.9.85 Crores and Rs.3.70 Crores respectively.
