## AGENDA NOTE :

Earlier, VUDA has taken up development of 80' wide Master Plan road from Arasavalli road at mill Jn., to Collectorate in Srikakulam. The work was completed except for a length of 30 M stretch at the starting point of Arasavalli road side. This stretch could not be completed due to existence of private lands, buildings and other encroachments.

Later, based on the request of District Collector, Srikakulam and the then Minister for Roads & Buildings (Ref - 1), it was considered to meet the amount payable for structural compensation of Rs.15,13,083/- by VUDA under the provision made towards land acquisition / alienation of Government lands in the Estate wing .

Accordingly, Vice-Chairman, VUDA has accorded sanction for Rs.15,13,083/- towards structural compensation and permitted to make the payment to Commissioner, Srikakulam Municipality in anticipation of approval of VUDA Board, (Ref- 2) since the District Collector, Srikakulam is also one of the Member in VUDA Board.

Subsequently, the subject matter was placed before VUDA Board during the Board Meeting held on 14-12-2013. Thereon VUDA Board vide resolution No.92, Dt.14-12-2013 resolved that "Additional Administrative sanction is agreed and the Structural Compensation should be recovered from the dues of the Local Body".

In accordance with the above, Commissioner, Srikakulam Municipality was requested to remit the amount of Rs.15,13,083/- to VUDA or to adjust dues payable to VUDA in respect of development charges or any amount payable to VUDA (Ref- 4).

In response Commissioner, Srikakulam Municipality vide their letter (Ref-5) requested VUDA Authorities not to insist for repayment of the amount of Rs.15,13,083/- for release towards structural compensation since the Srikakulam Municipality is not in a position to repay such a huge amount in view of the financial position and public interest.

In the above circumstances, the subject is placed before VUDA Board for perusal and to take a decision on the above
