AGENDA NOTE:

VUDA has procured a high end blade server, during the year 2012 to strengthen the IT / online services to the Citizens and to extend better services through VUDA. In order to facilitate secure and proper functioning of Server and its continues monitoring, a proposal for support personnel for Facility Management at VUDA Server Room was initiated as per the instructions. In this connection, the proposals from Department of Computer Science, Andhra University, Visakhapatnam and STPI, Visakhapatnam was examined in detail. In this connection, a Technical sub-committee was constituted with the officers having expertise in the field of Computers and I.T Administration. The committee has suggested for entrusting the services of Server Administrations / I.T services, to the agency who in turn shall engage one Data base Administrator and one Network Administrator to work on full time basis at VUDA Data Centre.

Accordingly out of STPI and A.U, the proposal of the Andhra University was taken into consideration and finalised. Hence the Facility Management was entrusted initially for a period of one year period with effect from 4-1-2013 to 3-1-2014, with annual service charges of Rs.11.75 Lakhs including service Tax at 12.36%.

The services of the Team headed by the Project Coordinator, Department of Computer Science, A.U is very much satisfactory, during the above period. Keeping in view of continuous and improved work load of I.T Services, web maintenance and online applications, the services of the Andhra University has been extended for another one year period upto 4-1-2015 with enhancement of 10% over the previous charges i.e. at Rs. 12.92 Lakhs including Service Tax. In the absence of regular IT wing in the organisation this sort of arrangement is must for initial few years. Besides, maintenance of services, few first time online initiatives have been taken with the help of above team. Hence, it is suggested that this sort of arrangement is required continuously for stabilizing the initiatives. Hence, it is suggested for continuation of this arrangement for some more time.

Hence the above subject is placed before the VUDA Board for favour of approval and ratification.
