Agenda Note:

The VUDA has introduced the IT enabled services to the public through various initiatives and it has engaged different players / agencies for doing the so but the in-house availability of experienced technical staff are lesser in number and hence, it is decided to involve the AU – department of Computer Science and System Engineering and accordingly, a MoU was signed between VUDA and Professor of Computer Science and Systems Engineering, Andhra University College of Engineering (Autonomous), Andhra University towards Establishment of Data & Facility Management at IT Cell, VUDA, Visakhapatnam Dr. Kuda Nageswara Rao, Professor of Computer Science and Systems Engineering as Project Coordinator vide references 1 and 2 cited., The Endeavour of the initiative is to develop public-friendly, easy to monitor and easy-to-deliver services of the Organization to the public.

Hence, it is decided to introduce ONLINE APPLICATION SYSTEM WITH the provision to GENERATE THE REQUIRED REPORTS AND TO GENERATE THE REQUIRED PROCEEDINGS from the application system to avoid delay and to have more transparency. This is attempted and being implemented for the public services like

- Application of vacant plots /flats / odd bits in VUDA developed layouts and housing projects
- Application for getting registration of the allotted plots / flats in VUDA developed layouts and housing projects
- Application for getting the sale permission of the registered plots / flats in VUDA developed layouts and housing projects

- Application for getting land use pattern of a survey number of land as per notified master plan
- Application for applying for the building plan / layout plan approval
- Application for vacant posts in VUDA to be recruited by DSC or VUDA ie other than APPSC
- LRS status of applications

Similarly, for the easier administration of the activities of VUDA, in the following areas, it is decided to involve online software to do the routine activities enabling better monitoring and quicker response

- Development of Court Cases Monitoring System for all the cases of VUDA in Honourable High Court, Lok Ayukta and Upa Lok Ayukta, APAT, District Court, Consumer Forums and other legal organizations
- 2. Development of software for entering all the transactions of the shops and establishments of VUDA
- 3. Green Visakha project
- 4. e-Office through IT Department
- 5. Scanning of all the files of various wings and having the scanned copies of files in the server under the reorganization exercise.

The following are the status of works being done with the above objectives.

I. The status of works done by AU-TEAM as per MoU

The following IT and IT enabled services are being offered by this arrangement.

1. Server Maintenance: VUDA has its own IBM 3-Blade Server with 8TB of SAS storage out of which Blade-3 is being used for hosting of VUDA website consisting of static and dynamic content of VUDA and the Mail Server. Blade-2 is being used for Video backup of VUDA Office Surveillance System and the third one is for various application software fulfilling the day to day needs of VUDA. Updating of Server side software, License

- renewals, regular updation of Symantic server based Anti-Virus and periodical preservation of Server Backup.
- Mail Server Maintenance: Blade 3 of VUDA IBM 3-Blade server is being configured with Mail Server and Electronic mail IDs were created in the VUDA domain (www.vuda.gov.in) for all the employees e.g. vc@vuda.gov.in
- Maintenance of VUDA website: The VUDA website www.vuda.gov.in is
 hosted in VUDA's own server with 99% up time consisting of static and
 dynamic content and updating the content on regular basis. The Internet
 connectivity is available with 10Mbps.
- 4. Configuration and Maintenance of CISCO Router 2800seris: The VUDA Internet Connectivity is well configured with the CISCO Router 2800seris and well maintained with more than 99% uptime.
- 5. **Maintenance of Firewall:** The VUDA Server and its Local Area Network (LAN) is well secured and protected with CYBEROAM-CR 25ia from all the malware and unauthorized access by the intruders.
- 6. **Network Administration and Maintenance:** The VUDA Server is located in IT Cell at 8th Floor of VUDA Udhyog Bhavan and its Local Area Network (LAN) spanned across Four floors viz. 3rd floor, 7th floor, 8th floor and 9th floor in VUDA Udhyog Bhavan, Siripuram, Visakhapatnam. The LAN is effectively maintained with all the nodes are well connected to the Main Server and the Client-Server Architecture is always up with zero down time.
- 7. System Administration and Hardware maintenance: The Client-Server architecture of VUDA was setup with 70 computers and other associated Peripherals and Network based Printers covering all the four floors. We conduct trouble shoot for Hardware and Software related issues day to day and rectify the problems on time and see that the working hours will not be get disturbed. As well, we are well maintaining the Ticket Issuing Systems at the KURSURA Submarine Museum, VUDA Park and Kailasagiri Toll gate.
- 8. **Maintenance of VUDA Office Surveillance System:** All the sections of all the wings of VUDA office is under Surveillance with well focused Network

based CC Cameras in the all the Four floors. Video recording is being done 24X7 with sufficient power backup and refreshed periodically after thoroughly inspecting the recorded videos for any susceptible/vulnerable incidents in the office.

- 9. **Provision of Online Services: The Cell has** developed and maintaining the following web enabled applications software.
 - a. In VUDA developed layouts, Online application system for sale of
 - 1. vacant plots by way of sale of auction
 - 2. vacant Flats in Row Housing at Rushikonda by way of sale of auction
 - 3. Odd Bits in VUDA developed layouts
 - 4. vacant Flats in HARITHA Housing project at Madhurawada, by way of drawl of lottery.
 - b. Online system for uploading of proceeding copies of
 - 1. approved private layouts into the VUDA website
 - 2. building permit orders into the VUDA website
 - c. Online application system for Registration of
 - 1. allotted plots in VUDA developed layouts.
 - 2. allotted Flats in VUDA housing projects
 - d. Online application system for Sale Permission
 - 1. for Registered plots in VUDA developed layouts.
 - 2. for Registered Flats in VUDA housing projects
 - e. Online application system for Land Use pattern/certification as notified in the master plan
 - f. Online Suggestion & Grievance system for the suggestions/complaints
 - g. Online provision for uploading of electronic copy of RTI applications

The services proposed at 'c', 'd', 'e' and 'g' are under the stages of testing and will be introduced soon. All these online application systems have the provision of generation of required online reports duly giving login and password at different level of working arrangement of the organization.

10. **Hosting of Other Online Services: The AU-Team is** hosting the following online services developed by other software agencies

- a. LRS Developed by the JITWORLD software solutions
- b. Building Plan Approval System Developed by FRUX software solutions
- c. Layout Plan Approval System Developed by FRUX software solutions
- d. Court case management systems Developed by FRUX software solutions
- e. Payment of dues of VUDA shops and establishments- Developed by FRUX software solutions
- 11. **Hosting of Information Related Services**: The AU-Team is hosting various information that is useful for the public in the VUDA website viz.
 - a. Acts and Rules
 - b. Board Resolutions of VUDA from 1962 to till date
 - c. List of VUDA approved layouts with proceedings copy and layout map
 - d. List of VUDA developed layouts with layout map
 - e. List of VUDA developed housing schemes/projects
 - f. Details of leased out Lands in VUDA
 - g. Details of PPP/BOT projects
 - h. Master Plan of Visakhapatnam Metropolitan Region (VMR)
 - i. Details of Harita housing project at Madhurawada
 - j. Rental details of Shops & establishments of VUDA
 - k. Details of Vacancy position of VUDA Shops & establishments
- 12. Hosting and updating of VK-PCPIR project: This Data and Facility Management IT cell is also hosting and updating the static and dynamic content of VK-PCPIR i.e. Visakhapatnam Kakinada Petroleum, Chemical and Petrochemical Investment Region project.

II. Services by other agencies

There are two agencies are involved. (1) For the development of application systems like online application system for building plan and layout plan approvals, the Frux Software is involved and this agency has also developed the software for court case monitoring system and for monitoring the transactions of shops and establishments of VUDA. (2) Similarly, the other agency, JIT World has developed the software like LRS, Engineering Wing Project Monitoring System with mobile source uploading, Green Visakha Project, etc. Except LRS and Green Visakha Project software, other software are not being extensively used.

The introduction of these services has started giving the results and all these services are at the crucial stage of the stabilization of online services and initiatives. Though all these software are hosted from the VUDA server, there are two compulsory prerequisites for making these transparent and public friendly initiatives a grand success.

- a. continuation of the maintenance of at least one year AMC for these introduced online services by the respective agencies are must for stabilizing these services and
- b. Scrupulous implementation of these initiatives by the HoDs duly sorting out the operation hiccups, thereon instead of keeping these initiatives aside and resorting back to manual mode.

Hence, the matter is placed before the board to order for the strict implementation of these online services duly improving and updating as and when circumstances warrant and also for the approval of maintenance of these introduced software for minimum of one year by way of AMC by the agencies like IT Team and Frux agency for stabilization of these public-friendly, easy to monitor and easy-to-deliver services of the Organization to the public.
