SUB: PLANNING – VUDA – Visakhapatnam – CRZ- Preparation of Coastal Zone Management Plans (CZMP) for VMR area – Expression of Interest (EOI) Called - Regarding.

Agenda Note :

In pursuance of the VUDA Board Meeting dated: 14-12-2013 vide Resolution No: 121, VUDA has issued a notification on 21.03.2014 inviting Expression of Interest (EOI) from the shortlisted agencies by CZMA, Govt of India to conduct CRZ study demarcate the CRZ area and preparation of Coastal Zone Management Plans (CZMP) as per CRZ Notification 2011. Within the stipulated time i.e, on or before 17.02.2013 two institutions have expressed their interest and quoted the rate as follows.


Sl.No	Name of the Institution	Rate quoted per Kilometer
1	Center for Earth science studies (CESS) - An R&D Institution of the Kerala state council for Science and Technology and Environment.	Rs. 50,000 per running kilometer of HTL
2	National Institute of Oceanography (NIO) - Council of Scientific and Industrial research	Rs. 1.00 Lakh per 1 Kilometer including creeks

Both the institutions have mentioned the rate per running kilometer whereas CESS has mentioned that the rate per running kilometer of HTL only and NIO has mentioned rate including the creeks. Since there is ambiguity in the unit rates quoted by the institutions and the study relates purely scientific both the institutions have called for negotiations on 14.03.2014 and requested them to come with detailed methodology for taking up the work, the time frame required for completion of the work etc.,

During the meeting it was informed by the **Center for Earth science studies (CESS)** that they will charge the price same as HTL line demarcation even for creeks also. Since, **Center for Earth science studies (CESS)** has quoted less price they were asked to come with the detailed methodology and terms and conditions. During the meeting, NIO has informed that they will also come up with detailed methodology to take up the above work with negotiable price

In view of the above, the matter is placed before the board for decision.
