AGENDA NOTE:

A paper notification was issued in Local News papers on 7-3-2007 calling applications for the post of Legal officer in VUDA on contract basis. Written test was conducted for the post of Legal officer and Sri S.Kesava Rao was selected for the post of Legal Officer with the following terms and conditions i.e. (1) The period of engagement on contract shall be for six months and it is purely on contract basis. (2) The Candidate shall not practice in any Court during the contract period. The period may be extended on review of performance at periodical intervals (3) The contract shall be terminated without notice if the services of the candidate are found not satisfactory or not required to the Organization at any time during the contract period (3) The contract appointment does not confer any right whatsoever on him to continue as Legal officer beyond six months. The contract engagement will automatically get terminated on the last date of the contractual period without any notice whatsoever etc.

As per the above selection procedure Sri S.Kesava Rao was appointed as Legal Officer on contract basis for a period of Six Months with remuneration of Rs. 15,000/- per month vide reference 1st cited. The said contract period was extended from time to time up to 11-8-2011. The VUDA also enhanced the monthly remuneration from time to time and the same was finally enhanced to Rs. 22,500/- per month with effect from 1-4-2011.

Sri S. Kesava Rao while working as legal officer on contract basis in VUDA has resigned to the post of legal officer on 11-8-2011 and the same was accepted by Vice Chairman, VUDA on the same day i.e. on 11-8-2011. Consequent on resignation of Sri S. Kesava Rao, Sri C. Rambabu, District &

Sessions Judge (Retd) was appointed as Senior Legal officer temporarily on contract basis in the place of Sri S. Kesava Rao, and he has assumed the charge as Senior Legal officer on 7-9-2011 A.N. and he has been working as Senior Legal officer presently in VUDA. The said appointment of Sri C. Ram Babu, District & Sessions Judge (Retd) as Senior Legal officer was ratified by the VUDA Board vide Resolution No. 2,dt.15-9-2011.

In the mean while, Sri S. Kesava Rao has requested the Vice Chairman, VUDA in his representation dt.9-12-2011 to permit him to withdraw his resignation and allow him to continue as the Legal officer in VUDA on contract basis. In response to his request, Sri S. Kesava Rao was informed vide this office letter R.c.No.87/2010/A1 dated.19-12-2011,that the VUDA has already appointed a senior Legal officer after his resignation. Aggrieved by the decision of VUDA,Sri S. Kesava Rao has represented to the Chief Secretary to Government of A.P. to consider his case for reinstatement as Legal officer and filed W.P. No. 4216/2011 against Government and VUDA and the case is pending in Hon'ble High court.

Now, vide reference 3rd cited, the Government has forwarded a copy of the representation of Sri.S.Kesava Rao with a request to reconsider his case for re-employment as Legal Officer on contract basis and directed to take further necessary action.

Hence, the matter is paced before the VUDA board to take a decision on the request of Sri.S.Kesava Rao for re-employment as Legal Officer on contract basis.
