AGENDA NOTE:

VUDA has proposed to take up development and widening of Master Plan Roads in city limits to open up new areas and provide better connectivity for villages - P.M.Palem, Kommadi, Nagarapalem, Bakkannapalem in Madhurawada area, Yendada, Rushikonda, Boyapalem and Kapulauppada Villages from National Highway-16 to cater the future needs keeping in view of the development of number of private as well VUDA layouts, Residential colonies, Educational Institutions, ITSEZs, Gated Community Housing Schemes in the above areas.

Apart from the above, GVMC Authorities have requested to take up certain important Master Plan Roads for the said villages by VUDA as GVMC is not in a position to take up the same due to lack of funds. Local MLAs and Residents Welfare Associations / Villagers of Kommadi, Bakkannapalem, Nagarapalem, Yendada have also represented VUDA and GVMC to develop the roads since the existing roads of narrow width are in bad shape and facing much difficulty.

In order to take up the development of Master Plan Roads, GVMC Authorities were requested to clear the encroachments duly resolving the Private Properties issues and to furnish Road Development Plans (RDP) for Master Plan Roads exists within the GVMC limits so that VUDA can take up the execution of works without any hindrance.

In response, GVMC Authorities furnished Road Development Plans prepared by the consultants for 80' wide P.M.Palem and 100' wide Kommadi roads without approval for guidance and to facilitate VUDA to start with the work informing that finalized RDPs will be furnished for the remaining roads in due course.

Accordingly, in anticipation of furnishing of approved Road Development Plans by GVMC, VUDA has taken up the development of certain Master Plan Roads. After commencement of execution of such works, VUDA used to face many problems i.e., site disputes, involvement of private properties and lands in the road widening portion, alignment issues and encroachments in the road portion including court cases. Because of the above, works could not be completed in time and prolonging indefinitely for want of clearance of TDRs and other issues by GVMC. Hence, VUDA Board has issued directions vide its VUDA Board Resolution No. 8 Dt. 20-07-2013, to take up the development of Master Plan Roads only after furnishing of approved RDPs and clearing of all encroachments and other issues by GVMC to avoid delay and court cases in land matters.

However, development of certain Master Plan Roads was taken up and completed without approved Road Development Plans and the remaining Master Plan Roads are at different stages. The status of Master Plan Roads so far taken up by VUDA is furnished hereunder.

As could be seen from the above, so far 10.80 Km length of Master Plan Roads in Madhurawada area were taken up and completed with an expenditure of Rs.30.79 Crores.

At present, work entrusted for 3 Nos. of Master Plan Roads at Kommadi Reach-II, GITAM University and Law College and are taken up for a length of 6.40 KM with an estimated cost of Rs. 20.60 Crores and arrangements are made to commence the work. Regarding, Road Development Plan of Master Plan Roads, the GVMC is addressed to solve the issues by few letters Dt. 09-04-2012, 18-05-2013 and 28-07-2013 (Copies enclosed).

Hence the matter is placed before VUDA Board for perusal and necessary instructions.
