The District Collector, Visakhapatnam has requested the Vice Chairman, VUDA to take up certain renovation works to Government Circuit House at Visakhapatnam with VUDA Funds in connection with the staying of observes in connection with general election 2014. In this connection, the DRO, Visakhapatnam has listed out certain renovation works like single coat painting to inside of suits, providing new furniture like sofa sets, Cot & Mattress, TV's, Air conditioners, wardrobes, providing Door curtains, Electrical and Civil repairs work etc.

The works are estimated and worked out to Rs.11,50,000/- as follows.


