SUBJECT NO. 85.

Read the letter D.Dis.No. 7633/68 D5 dt. 4-7-68 of Director of Town Planning, Hyderabad communicating the approved layout plan for the site in T.s.No. 538 of Kilipur Ward under T.P.No. 44/68.

3. 202/68	Sri B. Venkateswara Rao, Waltair Ward.	Permission for the construction of terrace buildings may be granted.
