Sub:-Planning - VUDA - Proposed construction of 2 sheds and One block of class room at Sri Vemana I.T.I. - Pedagantyada - approval of plans - Reg.

The Commissioner, Gajuwaka Municipality has forwarded the plans of Vemana I.T.I. for the proposed construction of 2 sheds and one block of class rooms in S.No.158/P,151/P, 152/P and 153/P of Pedagantyada.

The Vemana I.T.I. has already constructed 4 sheds (A.C.Roof) and one block class room and the I.T.I. is running from 1987-28. The Vemana I.T.I. has constructed unauthorisedly these sheds without approval either from Panchayat or from VUDA.

As per the sanctioned Master Plan, the sits is S.No.150,151 and 153 of Pedagantyada falls in partly Residential and partly Industrial. The site was handed over by Special Deputy Collector (L.A.) (REH) Steel Plant for starting a private I.T.I. for displaced persons of Steel Plant.

Since the Special Deputy Collector (L.A.) has handed over the lands for the surpose of I.T.I. and the Institute is functioning on ground, the party has been informed that the change of land use from partly Residential and partly Industrial to Institution use will be recommended to Govt., subject to payment of Rs. 77,703/- towards conversion fees at Rs.2/- per sq.mt of land, duly placing the subject before VUDA Board since the building was already constructed by the institute.

The Principle, Vemana I.T.I. has requested to exempt for payment of Rs. 77,703/- towards change of land use fee. The exemption proposal was sent to Government for consideration. Since there is no provision for exemption of development charges for educational Institution like I.T.I. except E.W.S. layout as per G.O.Ms.No. 164 M.A. dt. 6.2.93, the Government have rejected the waival of payment of Development charges of Rs. 77,703/- as requested by Principal, Vemana I.T.I.
