AGENDA NOTE:

Sri Ch.Venkateswara Rao, S/o.Late Sri C. Rama Murthy in his application has stated that he is eligible to hold the post of Junior Assistant on compassionate grounds and he belongs to S.C.Community. He therefore requested to issue appointment orders to maintain his family. He has furnished the copies of Legal heir, death extract of his father late Sri C. Rama murthy. Smt.Ch.Ratnam, W/o. Late C.Ramamurthy has given affidavit stating that she has no objection to provide the employment to her eldest son Sri Chinta Venkateswara Rao, as her eldest son has agreed to look after her and dependent sister and brother.

Sri C. Rama murthy, Sr.Asst., VUDA expired on 9-6-97 as per the Death Certificate issued by the Municipal Corporation, Visakhapatnam dt.10-7-97. Late Sri C. Rama Murthy was appointed as L.D.Clerk on 26-6-79 subsequently he was promoted as Senior Assistant and worked in this Organisation till his death i.e., on 9-6-97.

In this connection, it is submitted that as per VUDA Service Rules approved in G.O.Ms.No.560, M.A., dated: 29-6-82 and A.P.Ministerial Service Rules for appointment of Junior Assistant (L.D.Clerk) have to be passed a Degree in Arts, Commerce or Science aged below 30 years. The details of Sri Ch.Venkateswara Rao, S/o.Late C. Rama Murthy, Sr.Asst., are as follows:

Date of Birth .. 12-02-1975
 Educational Qualifications: Passed S.S.C.in the year March-1993.

According to G.O.Ms.No.612, dt.30-10-91 of G.A.D. The Government have relaxed certain Educational Qualifications in cases of compassionate appointment as per Para-viii of the said G.O. as follows:

Resolved to approve the proposal for appointment of Sri Ch. Venkateswara Rao s/o. Late Sri C. Rama murthy as Attender against the back log post of S.C. on compassionate grounds.

1. The minimum qualification required to hold the post of Jr. Asst. in the heads of Departments/ Directorates is Degree and in Sub-ordinate Offices Intermediate. The candidates for compassionate appointments who do not possess the said qualifications can be considered for appointment if they possess at least Intermediate/Tenth Class qualification respectively by giving reasonable time to acquire higher qualification prescribed under Rules to hold such posts.

In view of the above, Sri Ch. Venkateswara Rao, s/o. Late Sri C. Rama Murthy, Sr. Asst. is eligible for appointment of Attender since he has passed the 10th Class and he is eligible for Attender post in terms of G.O. Ms. No. 560, M. A., dt. 29-6-1982 applicable to VUDA Staff.
