Sub:-VUDA-Vsp.- Allotment of land measuring 192 sq.yards (60+132) in s.No.6 of Resapuvanipalem (v) of seethammadhara layout for "Construction of Anjaneyaswamy Temple - Ratification - Reg.

The VWDA Board in its resolution No.198, dt.24.2.87 has resolved to allot an extent of 60 sq.yards by the side of plot No.MIG.283 of seethammadhara layout in favour of the president, Anjaneyaswamy seva samithi for Construction of gri Anjaneyaswamy Vari Temple at Re.100/-per sq.yard.

Accordingly the above site was allotted in the year '87 to the said samithi. The samithi has paid full cost for 60 sq. yards amounting to Re.6,000/-.

The Pregident, Anjaneya geva samithi in his letter dt.24.2.'95 has requested that the earlier allotted site measuring 60 sq.yards, is not sufficient for construction of Temple and requested to allot the available vacant site towards northern side of the allotteed site which is in a irregular shape and it is not suitable for residential Building.

In this office proceedings dt.19.7.'95 the President Anjaneya seva samithi has been allotted an additional extent of 132 eq.yards by the side of the MIC plot No.283 of seethammadhara layout at Re.250/- per sq. yards for construction of Anjaneya swamy Vari temple as a special case and subject to ratification by WDA Boards as the 60 sq.yard site already allotted very back in 1987 is too small for construction of any temple if we wish to avoid spilling over crowds on the roads. The samithi has also paid the cost of 132 sq.yards amounting to

## VUDA RESOLUTION No. 16, dated 22---97.

Resolved to ratify the action of the Vice Chairman in having allotted an extent of 132 sq. yds by the side of the M.I.G. plot No. 283, of Seethammadhara layout @ Rs. 250/-per sq. yd. for construction of Anjaneya swamy vari temple as a special case.

Also resolved to consider outright sale instead of lease in future cases.

The District Collector in his proceedings dt.19.12.95 has accorded permission to the president gri Anjaneya seva samithi, seethemmadhara for construction of gri Anjaneya swami Vari Temple in the allotted extent of 192 sq.yards subject to the following conditions. The M.R.O. Vicakhapatnam inhis letter dt.9.9.96 that there are no objections raised from the Public of the neighbouring hood for the said construction of temple.

- i. that the Construction should be made within the 192 sq.yards allotted by the VUDA vide proceedings Rc.No.13/87 EM.I dt.30.9.88 and 19.7.95 of the Vice-Chairman, VUDA Visakhapatnam to sri Anjaneya seva samithi in s.No.6 of Resapuvanipalem village.
- ii. that the Construction should not be hurdle or endanger public peace and order in the area.
- iii. that the plan of the proposed construction of the temple should obtain approval of Visakhapatnam Municipal corporation.
- iv. that the construction should be made and use only for the Religious purpose.
