Based on the request of the Executive Officer, SVLNS Devasthanam, Visakhapatnam, Commissioner Endowment Department Hyderabad accorded permission to Executive Officer SVLN Devasthanam to entrust certain development works to VUDA, Visakhapatnam for proper execution of works the performs.

In accordance with the above Executive Officer, SVLNS Devasthanam has requested Vice Chairman, VUDA to take up the following works as deposit works stating that Administrative Sanction was already accorded by Commissioner, Endowment Department, Hyderabad for Rs 251.00 Lakhs. Estimates along with drawings were also enclosed for scrutiny and to accord Technical Sanction.


• Road around parking area at Sri Varahalakshmi Narasimha Swamy Devasthanam, Simhachalam	191.00
• Road from Tribal and parking area at Sri Varahalakshmi Narasimha Swamy Devasthanam, Simhachalam	52.00
• Road at rear side of PAC Building situated at Lova Thota area (Up Hill) at Sri Varahalakshmi Narasimha Swamy Devasthanam, Simhachalam	13.00
• Miscellaneous Works	4.00
Total:	260.00

On verification and scrutiny, the estimated cost for the said works is worked to Rs 260.00 Lakhs. The Vice Chairman, VUDA accorded Administrative Sanction for Rs 260.00 Lakhs and permitted to take up above works as deposit work as requested by SVLNS Devasthanam.

Further Commissioner, Endowment Department, Hyderabad was addressed for sanction for Rs 260.00 Lakhs (Revised cost) for taking up the above works and requested to release 50% of the funds in advance to take up the work by VUDA.

Later the Executive Officer and Special Grade Deputy Collector of SVLNS Devasthanam, Simhachalam has deposited Rs.130.00 Lakhs (50% of sanctioned estimate amount) and requested the Vice Chairman, VUDA to commence the works at the earliest.

Hence, the matter is placed before VUDA Board for perusal and permit to take up the above works.
