Layouts - Visakhapatnam Municipal
area - S.No. 33 part Allipur exten-
sion - approval of layout - Regard-
ing.

Note:-

Commissioner and Special Officer
in his letter No 12556/63 GS dt. 29-6-1963 referred
a layout submitted by Sri P.S. Chinoy in respect of
S.No. 33 part of Allipur extended area adjoining laxni-
pura layout. The layout has got access from two sides
from north and west from the laxnipura layout area.
The northern portion of the layout is covered by green
belt area by about 50' deep as shown in the plan.

The Director of Town Planning
may be requested to suggest a suitable layout for the
above site keeping in view the provisions of Master
Plan and remarks of the commissioner.

SUBJECT:- No. 34.

Layouts - Visakhapatnam Muni-
cipality - T.S.No. 33 of Resapu-
vanipalem village - Sri R. Rama-
nayya and Sri Shaik Sehabuddin -
approval of layout - Regarding.

Note:-

Read Town Planning Trust Resolu-
tion No. 27 dt. 1-7-1963 adjourning the subject to 8th.
It was suggested that the permission may be refused
for want of certain particulars. The petitioners have
since furnished the particulars called for through
the Municipality. Hence it was examined afresh.

The layout has been inspected
by me along with the Town Planning Assistants of the
Director of Town Planning's Office. There is another
approved layout adjoining this layout. He suggested a
revised layout for both these sites, which is placed
before the Trustee for consideration and approval.

SUBJECT:- No. 35.

Layouts - Visakhapatnam Muni-
cipality - T.S.No. 430 and 432 of
Block No 23 of waltair ward -
approval - Regarding.

Note:-

The Members of the Trust have
inspected the layout area covered by T.S.No. 430
and 432 of waltair ward on 19-6-1963 and suggested
a revised layout. Accordingly a suitable layout
has been suggested observing the waltair ward part
III Town Planning scheme provisions. Town Planning
Assistant who visited the place has also agreed with
the modifications suggested by the Trustees. The
trust is requested to consider the above revised lay-
out and approve the same, subject to the approval
of Director of Town Planning. A portion marked in
green colour may be revised for reconstitution of
plot in future, in view of the lane in T.S.No. 431
proposed to be given for road connection.


