

SUBJECT NO: 189

Read this office letter Rc.1065/71 dt.1-10-71 addressed to the Government informing that the Chairman will be proceeding to New Delhi on 5-10-71 with proposals under Revolving fund and other schemes under instructions of Sri I.K.Gujral, Union Minister for Works, Housing and Urban Development.

The Trust is requested to ratify the action of the Chairman in proceeding to New Delhi for discussion with the officials of the Ministry of Works, Housing and Urban Development, Chief (Urban Development) Planning Commission, Chief Planner, Town & Country Planning Organisation etc.

SUBJECT NO. 190.

Read T.P.T.R.No.111 dated 18-11-68 approving the acquisition proposals for T.S.Nos.40,41 and 42 of Waltair Ward x for proper development of the area and correspondence with the Special Tahsildar, Land Acquisition, Visakhapatnam Municipality, Visakhapatnam ending with this office Rc.1610/69-A2 dt.24-7-71 offering remarks on the objections received by him during 5 A. Enquiry.

Read proceedings Rc.6631/71-K1 dt.26-7-71 of the Collector, Visakhapatnam ordering elimination of the land measuring 3371 sq. yards from T.P.No.42 of Waltair Ward from the purview of acquisition by the Town Planning Trust, Visakhapatnam as the land was purchased by the Burma Repatriates on 3-1-70.

Read this office letter Rc.1610/69-A2 dt.23-8-71 to the Collector, Visakhapatnam stating that there is an approved layout for T.S.Nos.40,41,42,43 and 44 of Waltair Ward x that the Burma Repatriates may be advised to form plots as per the approved layout, that the Master Plan for the entire town and vicinity area was sanctioned by the Government, that Detailed Town Planning Schemes have been prepared and submitted to the Government and requesting him to keep the withdrawal proposals in obedience of till the Burma Repatriates agree for the above suggestion so that the plans of the Trust for the development of the area are not affected.

SUBJECT NO. 191.

Read this office letters R.C.No.336/66-A4 dt.15-3-69 and 22-9-7969 addressed to the Divisional Electrical Engineer, Visakhapatnam requesting to realign the existing H.T.33 K.V. and 11 K.V. electrical lines in Seethammadhara Trust Colony.

Read letter No.A.E/L/VSP/U/D.No.2142/69 dt.16-12-69 of the Asst.Engineer, Lines, Visakhapatnam requesting to send the acceptance of the Town Planning Trust for payment of Rs.29,270/- towards shifting charges of the electrical lines in Seethammadhara.

Read this office letter R.C.No.336/66-A4 dt.11-3-70 addressed to the Chairman, A.P.S.E.Board, Hyderabad requesting to waive the payment of Rs.29,270/- towards shifting charges pointing out that the Electricity Board previously issued orders that Electric poles have to be shifted free of cost if it is for Road widening Scheme.
