SUB:- U.D.A., VISAKHAPATNAM - Vehicles -  
Auction of Old Vehicles One Jeep (Petrol)  
and One Van (Diesel) - Additional expen-  
diture of Rs.1,80,243.67 incurred for  
purchase of New Jeep & Van - Financial  
Sanction - Regarding.

Two Old Vehicles of Visakhapatnam Urban  
Development Authority viz. Petrol Jeep APV 5071  
purchased in the year 1965 during erst-while Town  
Planning Trust and Van ADJ 4847 purchased in the  
year 1980 were proposed for auction as they cause  
frequent repairs as a result considerable progress  
could not be shown by the field staff besides, they  
consumes more fuel. The Government have been in-  
formed in this office letter Admn.No.10/86-A1,  
dated 03.01.1987 for the above position and also in-  
formed that the action would be taken for purchase  
of two vehicles in place of them.

Accordingly the auction of the above vehicles  
conducted on 30.01.1987 and 18.02.1987 for Jeep  
Van and in respect of Jeep the highest bid is  
Rs.15,800/- and for Diesel Van Rs.27,000/-. The  
above bid amounts were also confirmed by the Vice-Chairman,  
Visakhapatnam Urban Development Authority. The matter  
was placed before the VUDA in its meeting held on  
24.02.1987 and the Visakhapatnam Urban Development  
Authority has resolved to approve the ~~said~~ above ~~said~~  
action. ~~proposal~~.

A new Diesel Van has been purchased for  
Rs.1,08,267.67 including all additional fittings,  
accessories, license etc. The auction bid amount  
confirmed is Rs.27,000/-. The probable market value of

the van fixed by R.T.O., for re-sale is Rs.12,000/-.  
Hence the additional commitment in respect of purchase  
of new <sup>Van</sup> is Rs.81,267.67 only. The matter has been  
placed before VUDA and the VUDA in its Resolution  
No.218, dated 01.05.1987 have accorded financial  
sanction for the same.

Further a new Diesel Jeep has been purchased for  
Rs.1,14,776.00 including additional fittings, accesso-  
ries, Insurance License etc. The highest bid amount  
of auction of the Jeep has been confirmed at Rs.15,800/-  
Hence the additional financial commitment in respect of  
purchase of New Jeep in place Old one is Rs.98,976.00.

As such, the total additional expenditure incurred  
for purchase of New Vehicles in place Old ones  
is Rs.1,80,243.67. The additional expenditure involved  
in this ~~proposal~~ <sup>work</sup> may be met from Visakhapatnam Urban  
Development Authority funds, <sup>hence</sup> and financial sanction may  
please be accorded for the same.

The matter is placed before VUDA for according  
financial sanction for Rs.1,80,243.67.
