## AGENDA NOTE:

For regularisation of Plots bearing No. 24 & 25 of Madhamailand layout situated in S.No. 50/5 of Madhamadhara village for their approval. The Municipal Commissioner in Rc. No. 12016/90-G4. dated 15.06.1992 also sent proposals with Ground Plan.

The proposals have been examined in detail asfollows:

The Director of Town Planning Layout T.P.No.17/71 approved for S.No.50/5 of Madhavadhara village duly showing the open space at two places.

The central open space was already converted into plots. The other open space of 60° X 160° was made in to two plots and sold by the owner on the plea that the open space was shifted to the eastern edge of the layout as per the layout issued by Visakhapatnam Municipal Corporation. The plots have come into existence with numbers as 18 and 25 on ground. The said open space kept on the east has also been sold. This open space was earmarked as plot in the Director of Town Planning Layout. Hence, the second open space is not to be seen on ground and there is a deficit of 7% open space in the said layout.

The plot owners have purchased the plots have come for regularisation of the Plots, since their plots are effected by

Development Authority/Visakhapatnam Municipal Corporation, jointly and these plots are effected. A slight curve has been proposed to convert both ends of the 60' Master Plan road which has been marked on ground by which the plots are affected.

Regarding Plot No.21, an alternative site was already proposed to be given by Visakhapatnam Municipal Corporation, in the space left out for old 60' road (i.e.by the side of realigned 60' road).

In the other plots 24, & 25 an extent of 129.44 Si.yds. has been effected by 60' alignment and a reasonable compensation may be paid by the Visakhapatnam Municipal Corporation.

The layout which has been developed on the ground in deviation to the layout approved by Director of Town Planning may be considered for its regularisation due to the registration already made subject to fulfilment of the following conditions:

Handing over of road widening portion in advance to Visakhaparnam Municipal Corporation with compensation as per
regulations to form 60° wide scheme road asagreed by
the applicants of respective plots effected under
road widening.
