#### ORDER

The Visakhapatnam Urban Development Authority in its Resolution No.31 dated 12.4.86 delegated certain of the powers conferred under section 13,14,15,42 to 55 of Andhra Pradesh Urban Areas (Development) Act, 1975 to the Commissioner of Visakhapatnam Municipal Corporation and is extended upto 31.7. 2. Subsequently the Government in the G.O. cited have directed the V.U.D.A. to delegate certain additional powers to Visakhapatnam Municipal Corporation in respect of sub-division of plots, building plans, Multi-storeyed building plans and also demolition of buildings.

In accordance with the above Government orders and since the Board of Visakhapatnam Urban Development Authority is yet to be constituted by the Government, in anticipation of ratification by the V.U.D.A. and the powers of VUDA vested under section 13,14,15,42 to 55 of A.P. Urban Areas (Development) Act, 1975 in respect of approval of sub-division of plots, all building plans, multi-storeyed building plans and also demolition of buildings are hereby delegated to Visakhapatnam Municipal Corporation by virtue of powers vested under section 56 of Andhra Pradesh Urban Areas (Development) Lct, 1975. The above delegation shall come into force with effect from the date of these proceedings.

The delegation of powers shall be exercised in accordance with the development control rules, scheme conditions, layout rules, Master Plan Regulations and all other applicable Government orders as amended from time to time.
