The WUDA is at present having the following sanctioned staff in Engineer Wing.

1. Superintending Engineer.	1 Post.
2. Executive Engineers.	3 Posts with 3 Divisions.
3. Dy.Executive Engineers.	14 posts.
4. Asst. Executive Engineers/Asst.Engineers	38 posts.

Out of the above posts, the following are the temporary posts.

1. Superintending Engineer.	1 Post.
2. Executive Engineer.	1 Post.
3. Dy.Executive Engineers.	4 Posts.
4. Asst. Executive Engineers.	15 posts.

The sanction of the Government for continuation of the above posts is being obtained from time to time. The Government was addressed vide this office letter Rc.No.7701/89 A1 dt. 15.4.93 to accord sanction for continuation of all the above posts upto 31.3.94 in view of the work load.

In view of the large number of works proposed to be taken up during the year 1993-94 as detailed above, the present sanctioned staff strength in Engineering Wing is not sufficient as per the norms prescribed in G.O.Ms.No.22 T R&B dt. 23.1.82 (now converted to 91-92 S.S.R). Though the requirement of the staff as per the norms is very much higher than the sanctioned posts, the WUDA proposes to create only the following posts besides the sanctioned strength; The expenditure towards the salaries and emoluments of the staff now requested for sanction will be met from out of the Major and Petty supervision charges accrued on execution of the works.

1. Executive Engineer.	1 Post.
2. Dy.Executive Engineer.	2 Posts.
3. Asst. Executive Engineer/Asst.Engineer	6 posts.
