Sub:- VUDA, Vsp. - Allotment of VUDA sites of 570 Sq. Yds in Sector-7 of M.V.Palem Colony for erection of 33/11 of K.V.Sub-station by APSEB, Visakhapatnam in exchange of 457 Sq. Yds falling in the road formation at Gajuwaka High School road - Reg.

AGENDA NOTE

1. The VUDA has proposed to widen the existing 30' width road to 40' from New Gajuwaka Junction upto Gajuwaka High School besides forming 40' road from Gajuwaka High School to N.H.5 which is a very important link road for Gajuwaka Town. To take up the road it was assessed that an area of 250 Sq. Yds of land belonging to APSEB, Sub-station of Gajuwaka was required. Hence, the A.P.S.E.B., Visakhapatnam was requested in this office letter dt. 15.11.91 to handover the above land of 250 Sq. Yds to facilitate the VUDA to form the said road.
2. The Divl. Electrical Engineer, APSEB, Visakhapatnam in his letter dt. 26.11.91 has requested for allotment of 450 Sq. Yds of site in M.V.Palem Colony free of cost for erection of 33/11 K.V.Sub-station to cater the needs of the area.
3. The VUDA in its resolution No. 150 dt. 21.7.92 has resolved to take over possession of 250 Sq. Yds of land in Gajuwaka belonging to APSEB, Visakhapatnam in exchange of the land of 450 Sq. Yds in S.NO.30 of Pedawaltair (Sector 7 of M.V.P) belonging to VUDA or locating a Sub-station.
4. While fixing the alignment of 40' proposed road the extent of the site required from APSEB in Sub-station premises was found to be 457 Sq. Yds and not 250 Sq. Yds as worked out earlier.
5. At this juncture, A.P.S.E.B., Visakhapatnam has informed that the land of 450 Sq. Yds being handed over for 33/11 K.V. is not sufficient and requested to allot 570 Sq. Yds in Sector-7 of M.V.P. Colony.

6. According an extent of 570 Sq. Yds of M.V.PALEM Layout was handed over possession to A.P.S.E.B., Visakhapatnam and an extent of 457 Sq. Yds in Gajuwaka was taken possession from APSEB, Visakhapatnam for formation of 40' Road, pending approval of VUDA Board.

7. The matter is placed before the VUDA for approval/ratification of the handing over possession of 570 Sq. Yds in M.V.Palem Layout to A.P.S.E.B., Visakhapatnam and taking over possession of 457 Sq. Yds in Gajuwaka from A.P.S.E.B., Visakhapatnam.
