Sub:- Land Acquisition - VUDA - Acquisition of lands in S.NO.498, 513,514,515,517 and 518 of Vizianagaram Bit.II for widening of 100' Lower Tank Bund Road - Withdrawal proposals - Reg.

AGENDA NOTE

The WDA has proposed for acquisition of an extent of Ac. 1.20732 Sq. Ft. in T.S.NO.498,513,514,516,517 and 518 of Kaspa West Ward of Vizianagaram. Town to widen the Lower Tank Bund Road, ie., from R.D.D's office to Regional Manager's office, A.P.S.R.T.C. when the matter has reached & award stage, the then Vice Chairman has inspected the lands and opined that it may not be necessary to form the 100' Road from Ambedkar Junction to Old A.P.S.R.T.C. Regional Office as the traffic on this stretch of Road is very minimum. Hence 100' Widening of lower Tank Bund Road.from Ambedkar Junction to A.P.S.B.T.C. Regional Office Junction was dropped and the L.A. for the remaining part of 100' Lower Tank Bund Road from R.D.O's office to Ambedkar Statue Junction was processed. It was also decided that the L.A. for the road between Ambedkar J unction and Simhachalam Meda Junction be done by Vizianagaram Municipality as WDA do not have sufficient funds to take up the road widening. The Commissioner, Vizianagaram was requested to take up the Road widening accordingly. Hence, the Land Acquisition Officer was requested to process the L.A. from R.D.O's office to Ambedkar Junction to take up the 100' lower tank bund road widening.

In view of the above, the matter was placed before the WDA Board, to approve the withdrawal of L.A. in T.S.NO.498,513,514,516,517 and518 of Kaspa West Ward of Vizianagaram Town measuring extent Ac. 1.20737 proposed for Road widening beyond Ambedkar Junctio to A.P.S.R.T.C. Regional Office.

The WDA in its Resolution No.366 dt. 18.6.93 resolved to request the Vice Chairman, WDA to re-examine the matter after personal inspection of the lands along with Sri K.Gowri Shankar, the then Board Member. Accordingly the then Vice Chairman, WDA has inspected the lands. But joint inspection with Board M ember could not be done.

The matter has been re-examined. The VUDA is not in a position to afford to bear the huge L.A.cost and expenditure in Vizianagaram.Town as we are spending lot of amount on Ring Road formation.

In view of the above, the VUDA Board is requested to take a decision to withdraw the lands measuring Ac. 1.20737 in T.S. Nos. 498, 513,514,516,517 and 518 of Kaspa West Ward in Vizianagaram Town from acquisition of VUDA.
