Sub:- ESTABLISHMENT & VUDA, Vsp. Amendments to Sub-Section 3 and 5 of Section 3 of A.P. Urban Development Act, 1975 - Reg.

## AGENDA NOTE:

As per Section 3(3) of the A.P. Urban Areas (Development) Act, 1975 the Authority shall consist of the following members.

- a) Chairman to be appointed by the Government.
- b) Vice Chairman to be appointed by the Government who shall be a whole-time Chief Executive Officer of the Authority.
- c) Three members from among the Members of the State Legislative representing the development area to be nominated by the Government.
- d) Two Councillors of the Municipal Corporation of Hyderabad or of the Municipality as the case may be comprised within the development area to be nominated by the Government.
- e) One Officer, representing the Municipal Corporation,
  Hyderabad or the Municipal Administration Department
  of the Government to be mo nominated by the Govt.
- f) One Officer of the Town Planning Department of the Government, to be nominated by the Government.
- g) One Officer of the Finance Department of the Government to be nominated by the Government.
- i) Five other members to be nominated by the Govt.

Under Section 3(2A) of the said Agt, the

terms of Office of the members including the Chairman who
are appointed or nominated, as the case may be, shall
be one year initially from the date of such appointment
or nomination, which may be extended by the Government
from time to time and as per Section 3(5) of the said
Act, the members including the Chairman shall hold
Office for a term of three years from the date of their
apointment or nomination.

## : 2 :

In G.O.Ms.No. 113 M.A. dt. 24-2-1994, the Government have extended the term of present Chairman, VUDA upto 25-2-1995 (3rd year). The following Govt. Officers were nominated by the Govt. in G.O.Ms.No.154, M.A. dt. 17-3-94 as Members of VUDA for a period of one year from the date of issue of this order.

- Commissioner, Visakhapatnam Municipal Corporation, Visakhapatnam.
- 2, Director of Town & Country Planning, Hyderabad.
- 3. One Officer of the Finance & Planning (FW) Department.
- 4. Commissioner of Police, Visakhapatnam.

The Member "the Commissioner of Police" has not been covered in the Act. under Official quota U/s 3(3) of the Act.

Hence this matter is placed before Board to recommend to the Government to take a decision on the following:

- 1. To include the name of the Commissioner of Police, Visakhapatnam as a nominated Member to VUDA, under Official quota under Sec. 3(3) of the Act.
- 2 To increase the term of Office of the Chairman and Members from 3 years to 5 years by amending the Section 3(5) of the Act.
