In respect of sites in Rushikonda and Kapuluppada the last date for receipt of sealed quotations has been fixed on 28-9-94 and the allotments will be done on 28-9-94 and 29-9-94. Regarding the Sites and Houses/Flats in other layouts last date for receipt of applications has been fixed on 15-10-94 and same shall be allotted after scruting of applications as per approved allotment regulations and the allottees shall be asked to pay about 40% cost of sites with in a month and the balance 60% cost in a period of 2 years in 8 quarterly instalments.
