AGEIDA NOTE:

One post of U.D.Steno Typist was sanctioned in G.O.Ms.No. 958 M.A., dt.6-8-62 in the Erst-while Town Planning Trust. This post has been utilised at the Chamber of Vice Chairman, VUDA.

One post of Spl.Category Stenographer to Vice Chairman was created in the Scale of & 1330 - 2700 with effect from 13-1-90 in terms of G.D.Ms.No.590 M.A., dt.5-10-89 and promoted Sri K.L. Herasimha Murthy, U.D.Stenographer (Sr.Stenographer to Vice Chairman) as Special Category Steno-grapher with effect from 13-1-90 in the Scale of & 1330-2700 (1986 Pay Scales) vide this Office Proceedings 9370/88/A1/Dt.13-1-90 in terms of Draft A.P.U.D.A. Sub-ordinate Service Rules for the State prepared by the Government for the posts approved in G.D.Ms.No.590, M.A./dt.5-10-89, subject to ratification by the VUDA Board. The Board has ratified the action vide Resolution No.4 dt.15-2-92. The post of U.D.Stenographer has not yet been filled in.

The services of Sri K.L.N.Murthy were regularised with effect from 13-1-90 and declared his probation in the cadre of Special Category Stenographer on 12-1-91 A.N. vide this office Proceedings Rc.No.1558/92/A1/Dt.18-3-92.

At present the work load at the Chamber of Vice Chairman has been increased abnormally. Hence there is every need to create one post of P.S. to Vice Chairman.

In G.J.Ms.No.590, M.A., dt.5-10-89 constituting the A.P. U.D.As Sub-ordinate Service, the post of P.S. to ViceChairman has been covered. As per the draft service rules prepared by the Government for the cadres of the said G.J., the following is the Scale of Pay, method of recruitment qualifications etc.

As per the said Draft rules, the appointing Authority is the Government. As per Regulations 10(1) of the Act No.2 of 1994 of Andhra Pradesh (Regulation of appointments to public services and rationalisation of staff pattern and pay structure) Act 1994, no post shall be created in any office or Establishment without the previous sanction of Government. The post P.S. to ViceChairman has not been covered either in the VUDA Staff Recruitment & Servic Regulations approved in G.J.Ms.No.560 M.A., dt.29-6-82 or in the A.P.U.D.A.s Rules approved in G.J.Ms.No.611, M.A. dt.22-11-98 for the Officers or in the Ministerial Service Rules ordered to be followed by the Government by all U.D.A.,s in G.J.Ms.No.424, dt.4-8-94.
